- a) Taken print from www.incometaxindia.com for the correct TAN and address
- b) Seen that there is no other TAN of this person
- c) Name and Address is exact same as that in the website

#### Challan?

- a have the copy of the challans?
- b seen the challans on the website correct date, BSR and amount?
- c correct date required ( same as website )
- d (sometimes the BSR is not clear) pls fill up properly (in case of doubt, see website) www.tin-nsdl.com

#### **Deductee detail - name**

- a Do not use Mr / Mrs / Smt / Shri / M/s.
- b Names in CAPITALs only
- c Address, in separate line, and full
- d do not repeat address lines like " sector , faridabad "

a Rate must be as per LAW

b Rate if wrong, check, ask, get him to pay additional

c edu cess in all cases all types

## Service Tax Registration: Rental of Commercial Property

#### 1. when is this applicable?

- a. If you are renting a immovable property, for use in course of or furtherance of Business or Commerce.
- b. with a Rent of over Rs, 8 Lac p.a
- c. approx Rs. 66666 p.m. or more
- 2. Then, what?
  - a. Ask your landlord to get registered in Service Tax
- 3. what will he do?
  - a. He will have to issue a Service Tax bill, every month
- 4. What do I have to do?
  - a. And you will give him Extra Rent (for service tax + Edu Cess + She Cess)
  - b. Effective Rate = 12% + 2% + 1% = 12.36% of the rental value.
  - c. Also remember.

#### 5. Modvat?

- a. Yes
- b. If you are a Excisable factory, or a Registered Service Tax payer,
- c. You will get the MODVAT of this Service tax on Rent.

#### 6. What if I took it for Trading / Showroom / Retail Shop in a Mall etc?

- a. If you are running a office / Retail shop etc, you will usually not be registered in Excise or Service Tax
- b. So, either you or your landlord has to pay this from pocket ( NO MODVAT )

#### 7. My Rent was all inclusive / My rent deed is silent on this matter

- a. If your rent was all-inclusive → you have to discuss and settle it out.
- b. That landlord poor man, will not be able to give this service tax from his own pocket.
- c. And what about you? Of course, you will not like to pay this either.
- d. Common, settle it out

#### 8. Exclusions?

- a. Residential properties Excluded
- b. Religious bodies both as landlord and tenant = excluded
- c. Vacant Plot = excluded

#### 9. From when?



a. 1<sup>st</sup> June 2007

#### 10. What to do?

- a. Get yourself registered with the Service Tax Dept
- In Delhi Service Tax dept is at CGO Complex , near Nehru Stadium, Lodhi Road, New Delhi
- c. In Faridabad, Service Tax dept is at CGO Complex, NH-4, Faridabad








### Production Charts-Budget v/s Actual
